26th National English Language Olympiad for Technical University Students Regulations

§1 GENERAL PROVISIONS

- 1. Poznan University of Technology with headquarters in Poznan at Pl. Marii Skłodowskiej-Curie 5, postal code: 60-965 and Centre of Languages and Communication PUT, hereinafter referred to as "CLC PUT" with its registered office in Poznan at ul. Piotrowo 3a, postal code 60-965, hereinafter jointly referred to as the "Organizer", are the Organizer of the 26th National English Language Olympiad for Technical University Students, hereinafter referred to as the "Olympiad".
- 2. The Organizer appoints:
 - a. The Olympiad Organizational Team represented by lecturers and instructors of English from CLC PUT, which is responsible for organizational issues and assessing qualification tests, with the following members:

 Coordinator Edyta Olejarczuk, PhD and other organizers: Aneta Antokolska, MA, Agnieszka Łukasik, MA, Hanna Nowak, MA.
 - b. The Evaluation Committee, which is responsible for the verification of the results and evaluation of the participants' presentations, as well as awarding prizes, composed of: representatives of Poznan University of Technology, representatives of other technical universities and invited guests and sponsors.
- 3. The aim of the Olympiad is to examine the knowledge of English among students of technical universities, i.e. knowledge of the general language and technical vocabulary, as well as basic knowledge of the countries of the English language area.
- 4. The partners and/or sponsors of the Olympiad are enterprises, associations and institutions supporting the activities of the Organizer. The Organizer undertakes to place their logo in the Olympiad promotional materials, on the CLC website, on the Olympiad Facebook profile and on advertising boards in the conference room during the Olympiad finals. The current list of partners and/or sponsors is available on the Olympiad website.
- 5. The Olympiad's honorary patronage includes:
 - a. Rector of Poznan University of Technology,
 - b. Mayor of the City of Poznan,
 - c. Honorary Consul of the United Kingdom of Great Britain and Northern Ireland,
 - d. Honorary Consul of Ireland,
 - e. Polish-U.S. Fulbright Commission,
 - f. Afera Radio.

§2 PARTICIPANTS

- 1. The participants of the Olympiad are full-time and part-time students of the first, second and third cycle studies at technical universities in Poland, who enrol at the language centre at their university within the time specified in the announcements. Enrolment is made on the basis of a valid student ID.
- 2. Specific provisions regarding participation:
 - a. Participants of previous National Olympiads may take part in the Olympiad, with the exception of the winners from places 1 to 5 (from previous editions of the Olympiad).
 - b. Foreign students may participate in the Olympiad, with the exception of students from countries where English is the official language.
 - c. The participants of the Olympiad may not be students and graduates of linguistics and English language related fields.
- 3. Coordinators from individual universities are responsible for the verification of students enrolling in the first stage.

§3 ORGANIZATION OF THE OLYMPIAD

- 1. The 26th National English Language Olympiad for Technical University Students is a two-stage event.
 - a. Stage I is carried out in a stationary form at home universities of the participants,
 - b. Stage II the nationwide final, takes place on the Poznan University of Technology campus.
- 2. Students enrol for the Olympiad at their home universities with the Olympiad coordinator of the given university. The nationwide enrolment starts on 21 October 2024.
- 3. Students of Poznan University of Technology enrol for the Olympiad by registration via the Olympiad tab at CLC PUT website.
- 4. Registration for the Olympiad in the whole country is closed on 6 December 2024 at 23:59.
- 5. Coordinators of participating universities provide the list of participants after the registration at a given university is closed, i.e. by 9 December 2024 by 23:59 to the e-mail address provided by the coordinator of CLC PUT Olympiad.

§4 STAGE I - NATIONAL SEMI-FINAL

 Stage I will take place on Friday, 24 January 2025, from 12:00 to 14:00. These are written internal qualifications held at home universities based on the test prepared at CLC PUT in Poznan. Before taking the test, the participant is obliged to present their ID with a photo.

- 2. The Stage I test is sent to participating universities by priority registered letter and it cannot be obtained by email.
- 3. Coordinators reserve the copyrights to the Olympiad tests, as a result, the tests cannot be copied for commercial purposes and can solely be copied to be used at Stage I at home universities of the participants.
- 4. Coordinators are required to send tables with scores of students from their particular universities (to the address provided by the coordinator), as well as the tests, to the coordinator of CLC PUT Olympiad by 9 February 2025 by registered mail to the address:

5. The Organizer has the right to randomly verify the data sent from individual universities.

§5 STAGE II - NATIONAL FINAL

- 1. A total number of fifty (50) students who obtain the highest number of points on the test are qualified for Stage II, which consists of the following parts:
 - a. Written qualifications: Friday, 16 May 2025 at 12:00 (duration: 120 minutes, no break),
 - b. Oral qualifications: Friday, 16 May 2025 from 15.15: presentations.
 - c. Final: Saturday, 17 May 2025 at 9.00 10 students with the highest numbers of points obtained at the written and oral stages will participate in an Oxford debate. The names of these participants will be announced on Friday, 16 May, after 17:00.
- 2. Details concerning the organization of the Final will be sent to coordinators at participating universities and put on the CLC PUT website by 28.02.2025.
- 3. Detailed provisions on preparing the presentation:
 - a. Participants qualified for Stage II are required to prepare a multimedia presentation and choose one of the three topics given below:
 - "Live as if you were to die tomorrow, learn as if you were to live forever". -Mahatma Ghandi
 - "Real value in a world of infinite choice is someone making choices for you".
 - Ben Silverman
 - "In life, unlike chess, the game continues after checkmate". Isaac Asimov
 - b. The presentation at stage II must be prepared on two (2) different electronic media. The presentation cannot be read or recorded. Participants are required to use laptops provided by CLC PUT. It is forbidden for participants' to use their own laptops.
 - c. The duration of the presentation cannot exceed 7 minutes.

4. Final provisions regarding Stage II: If two (2) or more laureates obtain the same number of points in the final nationwide stage (total score after the written exam, multimedia presentation and Oxford debate), the order of winners is determined on the basis of the number of points obtained by students for the task/tasks testing technical vocabulary during the written examination.

§6 ORGANIZATION - ADDITIONAL PROVISIONS

- 1. Each participant of the Olympiad qualified for stage II is obligated to prepare a multimedia presentation (accepted formats: Power Point, PDF, Prezi).
- 2. At each stage, participants are required to bring a valid student ID card and ID, and present them at the Organizer's request.
- 3. During Stage II at Poznan University of Technology, a smart formal dress code is required.
- 4. The announcement of the winners' names, the places they have won and the awarding of prizes will take place after the debate.
- 5. In case of a laureate's absence during the final ceremony, the prizes should be collected in person no later than 1 month from the final date at the CLC PUT office. After this deadline, the prizes will be transferred to CLC PUT.
- 6. To participate in the Olympiad, it is necessary to consent to the processing of personal data referred to in Article 6 (1) a of RODO (GDPR).

§7 OLYMPIAD LAUREATES

- 1. The laureates of the 26th National English Language Olympiad for Technical University Students are the participants who receive the highest score (points in total) during the second stage of the competition: for the written part, the multimedia presentation and the Oxford debate on the final day.
- 2. The Olympiad laureates are selected by the Evaluation Committee.
- 3. The 26th National English Language Olympiad for Technical University Students announces 10 laureates.
- 4. All Olympiad laureates receive diplomas.
- 5. The laurates of Stage II, who are students of Poznan University of Technology, will be exempt from the written and oral parts of the English language exam with an entry of a *very good* grade in the examination protocol. Obtaining the title of laureate does not entitle you to receive an ACERT certificate.

§8 PRIZES

1. The winners of the 26th National English Language Olympiad of Technical Universities shall receive material and/or cash prizes.

2. All participants of the second stage of the Olympiad are asked to prepare the data regarding the receipt of the prizes (the form can be downloaded from the CLC PUT website), fill in and print the form and deliver it to the finals of the Olympiad. These documents will be necessary in order to collect the prizes.

3. If the value of the in-kind prize exceeds PLN 2,000.00 (in words: two thousand Polish zlotys), the Recipient is obliged to comply with Article 41 (7) 1 of the PDOF Act, and pay a tax of 10% of the total value of the prize. The issue of a non-cash prize in excess of PLN 2,000.00 (in words: two thousand Polish zlotys), will take place after the tax obligations under the Act of 26 July 1991 on personal income tax have been settled.

4. The payment of the cash prize can only be made after the form has been filled in. Tax value will be subtracted from the cash prize before payment, if such tax results from other regulations applicable hereto.

5. The Award Protocol of the 26th National English Language Olympiad for Technical University Students is sent to the PUT Bursar's office.

§9 FINAL PROVISIONS

1. The Organizer reserves the right to amend the Regulations.

2. In matters not covered by these Regulations and in disputes, decisions are made by CLC PUT Management.

3. The Regulations of the 26th National English Language Olympiad for Technical University Students were adopted at the CLC PUT Council Meeting on 16 October 2024.

§10 PERSONAL DATA

- 2) Each Co-administrator has appointed a Data Protection Inspector. - 3) The purpose of processing is the organizing and holding the 26th National English Language Olympiad for Technical University Students.
- 4) Your personal data can be made available to authorized employees of Coadministrators and entities entitled to carry out checks.
- 5) When necessity arises, your personal data may also be made available only to entities entitled under binding law regulations.
- 6) Your data shall not be transferred outside the European Economic Area.
- 7) The data obtained for the purpose of carrying out the 26th National English Language Olympiad for Technical University Students will be stored for the period required for meeting the objectives as referred to in point 3 of this Information and as long as the claims remain valid. Then, as regards archival materials, data storage will be in accordance with Office Instruction developed by each Co-administrator individually, on the basis of the provisions of the Act of 14 July 1983 on National Archive Resources and Archives.
- 8) In case your consent is withdrawn, the documents submitted on the basis of this consent shall be rendered anonymous if one of the conditions set out in Article 17 of RODO is met, e.g. the data is no longer necessary to meet the objectives for which it has been collected.
- 9) You are entitled to:
 - a) the right of access to your personal data obtaining confirmation from the Administrator that your personal data is processed and, should that be the case, gaining access to that data and obtaining information within the scope indicated in Article 15 of RODO;

- b) the right of withdrawal of the consent for the processing of your personal data. The right to withdrawal at any moment does not have bearing on compatibility with the right to data processing done on the basis of the consent prior to its withdrawal;
- c) the right to rectify your personal data requests from the Administrator to immediately rectify incorrect data and complete it, in accordance with Article 16 of RODO;
- d) The right to remove your personal data request from the Administrator to immediately remove personal data, if one of the conditions set out in Article 17 of RODO is met, e.g. the data is no longer required to meet the objectives for which it has been collected. The right to remove data may be limited because of the Administrator's responsibilities under existing legislation;

10) Submitting your personal data is voluntary, but necessary to participate in the Olympiad.

11) Your data will not be processed in an automated way, including in the form of profiling.
